DISCUSSION:

Denis McKinnon stated Joint Resolution #07-2022 between the City of Gulf Breeze and Capital Trust Agency includes a provision requiring the Agency Board to provide a recommended Minimum Reserve Requirement for the City Council's consideration.

Harry Wilder asked how the \$800,000 minimum amount was determined. Denis McKinnon stated that it is a compromise between what he would like to see in reserves and what the City Manager proposed as a desirable amount. Bob Cleveland added, if we had a bad year, it would be necessary and reasonable to have a sizable reserve in place.

Denis stated that CTA generates the majority of total revenues and as a result, carries all operating expenses. However, this is expected to change as the Authority begins operations and

generates new revenues. Denis further stated that the goal is for the agencies to split expenses, however, this will not occur until one agency (CTA) has less than 80% in total revenues.

Bob Cleveland made a motion to ratify the previously approved FYE 9/30/2023 budget with the additional recommendation of an \$800,000 reserve requirement. Chris Kemp seconded. Vote for approval was 5-0.
